The second coupon payment will be simple average of previous four quarterly coupon rates setting e.g. coupon rate to be paid on November 27, 2023 will be the simple average of coupon rate setting (rounded off to 2 decimal place) as on November 25, 2022, February 25, 2023, May 25, 2023 and August 25, 2023.

The ninth such coupon rate setting for the said debenture will be on November 25, 2023.
